# **Contracting During the COVID-19 Crisis**

#### **Declaration of National Emergency:**

IMPACT: A Presidential Proclamation on Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak was issued on 13 March 2020. As a result, DISA implemented several DARS (DISA's Supplement to the FAR/DARS) acquisitions flexibilities for COVID related requirements.

#### **Open Letters to Contractors and Mission Partners**

IMPACT: The Head of the Contracting Activity (HCA) has issued two open letters to contractors and one open letter to DITCO's mission partners in an effort to provide transparent communication. The first open letter to contractors discusses DISA's valued partnership with industry during this COVID-19 pandemic. The second open letter to contractors regarding Defense Industrial Base (DIB) and provides as an enclosure the Office of Undersecretary of Defense (OUSD) letters regarding DIB Considerations. The open letter to mission partners discusses DITCO support during this pandemic. The letters are under the Vendors tab on https://www.ditco.disa.mil/.

# **Contracting During the COVID-19 Crisis**

Corona Virus Aid, Relief, and Economic Security (CARES) Act (Pub. L. No. 116-136)

IMPACT: In response to this national emergency, on March 27, 2020, the President signed into law the Coronavirus Aid, Relief, and Economic Security Act (CARES). Most notable within the act is Section 3610, Federal Contractor Authority, which provides discretion for the agency to modify the terms and conditions of the contract to reimburse paid leave where contractor employees could not access work sites or telework but actions were needed to keep such employees in a ready state. DPC has provided implementing guidance via FAQs.




